GUIDELINES, TIME AND ASSOCIATED COST TO GUIDELINES, TIME AND COST ASSOCIATED WITH OBTAINING DRIVERS LICENSE IN IMO STATE

O V E R V I E W

A driver's license is a legal document issued by the Federal Road Safety Commission (FRSC) that confers the right to drive to an individual. In accordance with the Federal Road Safety Commission (Establishment) Act, 2007' Section 5(h). Anyone older than 18 years old is eligible to obtain a driver's license in Nigeria who wants to obtain driver's license must follow the guidelines below:

1	Obtain Driving School Certificate <i>Agency:</i> Accredited Driving Schools Attend training at an accredited driving school.	30 days	NGN500
2	Complete the driver's license application form online. <i>Agency:</i> Federal Road Safety Service Commission Complete the driver's license application form at the Drivers Licensing DLC or apply online at https://www.nigeriadriverslicence.org/ . Application form is free	1 day	No charge
3	Driving Test <i>Agency:</i> VIO Once you pass the driving test, you will be given a certificate of proficiency from the VIO and present your driving	5 days	No charge

	certificate to the Vehicle Inspection Officer (VIO) for a driving test. If you pass the test proceed to the next step. Immediate Temporary License duration license that would last for 3 months will be issued		
4	Pay the license fee online or at designated Bank. <i>Agency:</i> Federal Road Safety Service Commission (FRSC) & FIRSC Designated Banks. If you applied online, print your acknowledgement slip once the payment is verified. The link to the online payment at https://www.nigeriadriverslicence.org/ under Apply	1 day	NGN15,000 for 5 Years Driving License certificate & NGN10,000 for 3 years Driving License certificate
6	Confirm payment at Imo State Internal Revenue Services <i>Agency:</i> Imo State Internal Inland Revenue Services. Present your application form/slip to the Imo State Internal Inland Revenue (BIR) Officer and VIO at the DLC for endorsement.	1 day	No charge
7	Proceed to the FRSC office at the DLC for biometric data capturing <i>Agency:</i> Federal Road Safety Service Commission (FRSC) Proceed to the FRSC Officer at the DLC for biometric data capture	1 day	No charge
8	Visit Imo State DLC/MLA. VIO and present your application your application form or temporary card to pick up your original license card <i>Agency:</i> Imo State Internal Revenue Services Obtain a temporary driver's licence valid for 60 days AND pick up the original driver's licence at the Imo State Internal Revenue Service's Office after 60 days	60 days	No charge
