## APPLICATION PROCESS AND GUIDELINES FOR OPERATING PERMIT FOR UNPAINTED TAXI COMPANIES/SERVICES IN IMO STATE

In pursuant of Imo State Citation and Revenue Administration Law, 2021 (see <a href="https://imostate.gov.ng/IMSG/Common/Services/SFTAS\_4">https://imostate.gov.ng/IMSG/Common/Services/SFTAS\_4</a> pg54-141), all individuals and organizations seeking to load and offloading in Imo State can apply through the following process and guidelines:

Applicants are also required to pay a yearly registration fee of N= 10,000 to the Ministry to cover ATMC biometric Registration, MOT's operating stickers/permit and ID card. Renewal shall be at a fee prescribed by the Honorable Commissioner for Transport.

Applicants whose documents are not cleared will be issued an Incomplete Application Notice telling them of the affected document(s) to be rectified.

All successful Applicants will be issued operation permit to operate in the State as a licensed un/painted taxi operator after having returned the signed Acceptance Letter with evidence of payment of all fees to the schedule officer, Office of the Director Transport Operations Unit.

Successful Applicants will be notified by phone and or by email when their Permits are ready for collection. All collections shall be made at the schedule officer's office Imo State Ministry of Transport, F2J7+5QR, Port Harcourt Rd, New Owerri 460281, Owerri, Imo, Nigeria within the hours of 8 a.m. and 4 p.m., Monday to Friday (excluding public holidays). The licensing processing period after all Fees and Charges are paid is twenty working days (20 working days). However, contact the Director, Transport Operations Unit if you have not received your collection notification after ten (10) working days.
