On May 6, 2022, I tried to make contact with the Director Of Works And Services of Imo State University (IMSU), Mr Vernatius Igiri, but he was unavailable as he was out of town to attend a burial; I also tried to get the nine letters for the kings of the places that either showed resistance or that is yet to be approached, but due to lack of toner in the office, that was not achieved as well. The events of the day were unfortunately slow as there was a lot of delays and time waste.

REPORT 17 ON ASSIGNMENTS BY CHRISTIAN EZETAH:

On May 10, 2022, letters were delivered later to Graceland Estate Amakohia-Irete road, and Royal Gardens Estate Area UA New Owerri. I was also assigned to lead four teams - Teams 10, 16, 49 and 96 - to revisit some estates yet to be enumerated. We found out that Hiltop Estate, Riverside Residences and Arugo Gardens Estate were already enumerated; Pocket Layout Estate and Aladinma Estate were partially enumerated so we completed the enumeration today.

REPORT 19 ON ASSIGNMENTS BY CHRISTIAN EZETAH:

On May 12, 2022, I was taken by Mr Malcom C. Nwokoro to meet with one out of five Chairmen of the five towns in Umuoma Autonomous Community, Mr. Emeka Iwuala, to know the protocols needed to be executed for them to give us access to carry out the enumeration exercise; in summary, he made us understand that expenses will be made (even to deliver an official letter to the king would require a gift of kola nuts and wine) for announcement and safe passage. I then led Teams 16 and 49 to Transegbu Estate to count but we found out that it was already counted, so we decided to go to the houses in Toronto that had not yet been counted. We also found out that Worldbank Estate and Imo Housing Estate have been enumerated as well. While they were counting, I left them to collect the letters to kings from the HR Finance in the Commissioner's office by 12 noon, which I intend to deliver tomorrow, Friday 13 of May, while the Teams 16 and 49 go to their assigned grids.

REPORT 20 ON ASSIGNMENTS BY CHRISTIAN EZETAH:

On May 13, 2022, I was instructed by Mr Abdul to visit Alvan Ikoku Federal College Of Education concerning access which I did and I was able to secure access for the enumeration exercise. Then I delivered a letter to the Rector's

office of Federal Polytechnic, Nekede, and also secured access on the condition that I call back to tell them when exactly we'll be coming and we identify ourselves on the chosen date at the Rector's office before carrying out the exercise. I also went to Ihiagwa to deliver a letter to the king only to find out that the king the letter was addressed to was dead and two new kings had emerged, so I took their necessary information for new letters to be typed; the same thing for one of the kings for Owerri North (Eze Charles Osuji) at Akwakuma, who I found to be dead and there was yet to be a replacement. I also delivered a letter to the king of Agbala Ancient Kingdom (Eze Malachy OkechukwuOnu), but he said he would only allow the enumeration exercise when we have given letters to all the Owerri North kings; so I went to the HR's office for the list of all the communities in Owerri West and Owerri North and their kings, but the HR promised to look for it and send it to me.

REPORT 21 ON ASSIGNMENTS BY CHRISTIAN EZETAH:

On May 14, 2022, I worked with Mr Idika (Emmydan) as instructed by Mr Kunle to show him the location & names of the estates within our project areas we've worked on. Due to network issues and after awhile, I took permission from Mr Kunle to go and deliver letters to the personalities whose letters were already in my care; but due to the complaints coming from field workers at Ihiagwa and not wanting the day to go without working, Mr Samuel Inwang (Supervisor for Teams 24-29, 96 and 99) pleaded that I first go and see if I could convince the king of Obinze to let his field workers work (since Obinze was close to Ihiagwa, making it easier for the workers to move) while we prepare an official letter, which I did; but it turned out that Obinze had been divided into two autonomous communities, and one king said "No", while the other was inaccessible. I moved from there to deliver letters to His Royal Highness Eze Sir Dr. Ethelbert C. Ekwelibe Of Irete Autonomous Community, Engr. Vernatius Igiri, Director Of Works And Services in Imo State University, Owerri, and His Royal Highness Eze Francis Elendu Agunwah of Obazu Autonomous Community, but I succeeded only with the latter as the others were out of town and no one was available to acknowledge on their behalf.

REPORT 22 ON ASSIGNMENTS BY CHRISTIAN EZETAH:

On May 19, 2022, letters were delivered to H.R.H. Eze Henry Madumere, Eze of Ezi Mbieri Autonomous Community, Achi Mbieri, H.R.H. Eze Josiah Osuji, Eze of Obi Mbieri Autonomous Community, Umuahii Mbieri, H.R.H. Eze Sir Lucky I. Ajoku, of Amachara Umuchima, Ihiagwa Autonomous Community, and H.R.H. Eze Kingsley Ezewunwa Odu of Dindi, Ihiagwa Autonomous Community. Contact was made with Engr. Vernatius Igiri, the Director of Works And Services, IMSU, but he said he would not take a letter without one addressed to the Vice Chancellor of the school; so I went to the HR in the Commissioner's office to prepare it but due to some delay, the administrative office in IMSU was closed before Queen could get to them while I was delivering the letters at Ihiagwa.

IMSU said the letter to Engr. Vernatius, the Director of Works and Services, was no longer necessary once the letter to the Vice Chancellor was there, so we didn't have to give out that letter.

His Royal Highness Eze Peter Opara rejected his letter because it didn't have Mbaitoli L.G.A. mentioned as one of the L.G.A.s to be enumerated and he felt he shouldn't endorse for other L.G.A.s; and the letter to the President General of Owaellu Community, Mr. Jonathan Okpara was not delivered because there was a realization that he was not the main personality to seek official audience and awareness with when there was a higher authority - the king himself - present; plus the fact that the enumeration exercise was already being carried out.

REPORT 25 ON ASSIGNMENTS BY CHRISTIAN EZETAH:

On May 24, 2022, I went to the Mbaitoli Local Government and Owerri North Local Government to discuss the situation of constant resistance from certain communities under their jurisdictions and to come to a solution about it. Neither of the Local Government Chairmen was on seat, but I was able to meet the Chief Of Staff of the Owerri North Local Government, Mr Charles

Onyewuchi, and after a phone conversation with the Chairman, the Chief Of Staff gave us a list of the traditional kings, their President Generals and the autonomous communities in Owerri North. With the list, I reconstructed the letter (according to Mr Kunle's instructions) that would be delivered to the kings and sent it to the HR Finance for both vetting and printing. I proceeded to the Government House to collect some more letters previously prepared to be delivered. I called the Owerri West Local Government Chairman earlier on to know when he'd be on seat but he said he would call me back to tell me when to meet him at the office, which he never did, and the delays from heavy traffic jams and waiting for the letters at the Government House stopped me from going to the Owerri West Local Government to hopefully meet the Chief Of Staff as the day was spent.

REPORT 26 ON ASSIGNMENTS BY CHRISTIAN EZETAH:

On May 25, 2022, I had discussions with the Chairman Owerri West L.G.A. and the PRO for Traditional Rulers in Mbaitoli L.G.A. and I collected a list of traditional rulers and president generals from both for them to be prepared into letters by the HR Finance. A letter was also delivered to HRH Eze Edmund A. Njoku of Egbeada Community; attempt was made to deliver letters to Eze Francis OgbonnayaObiakonwaUgorji of Naze Autonomous Community who was not on seat and had no one at the time to acknowledge receiving the letter on his behalf, and Eze Peter Opara of UmuezeMbieri Autonomous Community who was having a cabinet meeting and therefore was inaccessible.

REPORT 27 ON ASSIGNMENTS BY CHRISTIAN EZETAH:

On May 26, 2022, I went to Ngor-Okpala LGA headquarters to speak with the Chairman, but no one was on seat because of the sit-at-home situation; however, I managed to get his secretary's number and booked an appointment for tomorrow. I also helped to resolve a situation and dissolve a case of another resistance at Ihiagwa. Letters were also delivered to His Royal Highness Eze Francis OgbonnayaObiakonwaUgorji of Naze Autonomous Community, and His Royal Highness Eze Peter Opara of UmuezeMbieri Autonomous Community.

REPORT 28 FOR MAY 27, 2022:

On May 27, 2022, I went to Ngor-Okpala Local Government Headquarters to speak with the Chairman. Although he was not on seat due to primary elections going on, I was able to deliver a letter to him and a message through his Secretary which I called later to confirm he had got them. An outreach attempt was made for Owalla but it turned out that the place was already enumerated, so the letters were not delivered.
